The 1993/1994 season will be remembered as the year of the long hot summer. I personally can not recall a better one in my years as a lifeguard. All seventeen patrols experienced crowded beaches with swimmers staying on till the sun went down. Consequently our patrolling hours were often extended well past the normal 5pm finish, with numerous rescues performed during the later hours.

P R E S I D E N T ' S R E P O R T



The efforts of our 1,257 Volunteer and 45 Professional Lifeguards deserve special recognition, working 51,159 man hours. The record number of rescues 1,010 doubled last seasons and exceeded the previous record year 1991/1992 by 202. It is apparent that the efforts of both District and Club Administrators to better equip, train and fund our

lifeguard have been warranted.

The Association and its clubs have been fortunate in the past year to have achieved increased levels of funding, from traditional sources as well as new sources. This has had an immediate and beneficial impact on the services provided. The commissioning of our new regional radio communication network, made possible with a special of grant of \$225,000 from the New Zealand Lottery Grants Board, improved our inter-club communications and provided essential links to other emergency services on several occasions.

The ASB Charitable Trust announced its very sizable donation of \$436,000 which goes to the fifteen clubs in its region, and toward the training and patrol operations conducted out of the Marine Rescue Centre by the Association.

Together with the grant aid paid by SLSNZ from the Lottery Grants Fund it ensures all clubs have adequate operational funding in the short term, thus allowing the Association to recover from the significant funding out flow to the clubs it has had to sustain in recent years.

The Association continues to recognise the need to plan and provide for the future. Clubs have now approved a new constitution that establishes a re-defined Board of Directors to manage financial, policy and strategic issues, and two new boards:

- Board of Surf Life Saving
- Board of Surf Sports

These will concentrate on matters applicable to each area of expertise, and report back to the Board of Directors. This stream lining of administration should enable our volunteers to concentrate their enthusiasm where their main interest lies, thus creating a more dynamic movement.

Finally I wish to thank on your behalf Graeme Danks, our Chairman for the past three years, for his efforts and direction. Members of Management for your dedication to our movement. ASLSA Trustees for guidance in funding, and Tim Jago and our professional staff whose efforts have been instrumental in securing the funding for special project. Thank you.

CHAIRMAN'S REPORT



The past season has been one of our busiest and rescues have been at an all time record. This has proved to be an added burden in dollar terms to the Association and clubs. The Association will run at an operating loss this season, which is regrettable, but mainly due to increased operating costs and income levels not meeting expectations.

The year has seen the last of a complete restructure of the Association and should now provide quality service and direction to our clubs. This has been brought about by the united and visionary approach of your committee over the past five years. This programme is now completed and more and the Association must now move forward to the end of the decade with the majority of our Clubs now in a good position to meet these new challenges with the assistance of the generous ASB Community Trust Grant.

The main problem the Association now faces is that for four of the past five years we have run at a loss. This situation means we have carried these deficits over from year to year, and despite our very best efforts we still have a shortfall in funds again this year. The new Management Committee will have to address this problem urgently if our dreams are to be achieved and some solutions are now in place to help achieve this goal.

Our sponsors have continued to provide excellent support to the Association and may I extend my sincere thanks for their continued support. Also special thanks to our Trustees who are now working in the direction of increasing the trust fund to achieve returns for future years.

As your Chairman for the past three years I have found it very rewarding. My personal thanks must go to all those people who have served on the Management Committee during my chairmanship. We have had good debates, made many decisions which have been for the good of the Auckland district and its Clubs. It has been my privilege to work with such a very dedicated group of people who give their time freely for the betterment of surf lifesavers and clubs.

To Tim and our professional staff, thanks for another dedicated year of change and a job well done. Your efforts have not gone unnoticed.

OPERATIONAL OVERVIEW

An unsatisfactory year end financial result detracts significantly from an otherwise momentous year in which there have been many excellent achievements, and commendable performances in all aspects of our activities. Achievements of note include:

- 1010 rescues, 24,508 preventative actions and 654 first aids - half the lifeguarding activity undertaken nationally.
- Commissioning of a new regional radio network linking all patrols and other emergency services.
- Obtaining a \$436,368 grant from the ASB Charitable Trust, toward club equipment and patrol operating expenses.
- Introduction of new beach safety education programmes and revitalisation of schools based programmes.
- A reconstruction of the Association to better reflect the differing management requirements for lifeguarding, and lifeguard competition activities.
- Staffing reviews to attain appropriate skill and remuneration levels.
- The Trustees continuing delivery of sound returns on investments.
- Triumphs over Californian lifeguard teams both at home and abroad.
- Mairangi Bay again winning the Kelloggs Surf League.
- Valuations of all Association and club assets, and creation of a centralised asset management programme.
- Hosting the national youth festival at Whangaparaoa.
- Winning the NZ rights to bid internationally to host the 1998 World Life Saving Championship and Congress.

The Association continues to encounter a number of difficulties which impact on our ability to effectively and efficiently deliver programmes and services. The more critical issues confronting the organisation at present include:

- Recruiting and retaining sufficient members to provide adequate voluntary patrols for the duration of a six month patrol season.
- Generating sufficient income to meet current operating expenses, and the 'nickel and dime' approach to core funding.
- The vast geographic distribution of patrol locations.
- The competitive threat posed to membership and funding by other sporting and community organisations.
- Entrenched community expectations that lifesaving will be provided on a philanthropic basis, in a user pays society.

A number of immediate operational objectives have now been identified, intended to secure the long term viability of the Association, it's programmes and services.

- Achieving legislative recognition of lifeguarding organisations, including a mandatory funding mechanism and lines of authority.
- Working together with local authorities and other emergency services to identify responsibilities, and the extent of liabilities.
- Meet the training needs of members to minimise exposure in terms of Occupational Health and Safety legislation, and civil litigation.
- Strategic positioning of clubs and voluntary patrols as cost effective deliverers of lifeguard services, alongside professionals.

- Entering into long term funding arrangements with regional health authorities, the Accident Rehabilitation Compensation Insurance Corporation and the insurance industry.
- Providing mid-week and peak period professional lifeguards to local authorities on a contractual rather than ad-hoc, grants funded basis.
- establishing "Surf Sports Limited" as a separate entity to provide lifeguard competitions.

The Executive is acutely aware of the need for the Association to be managed in a businesslike manner, as with any manufacturing company, retail firm or government department. 'Not for profit' is a description of the Association's legal tax status, not it's business philosophy. The Association must be funded beyond the 'break-even' level if it is to provide future services commensurate to demand. Where this cannot be achieved by growing income it will be necessary to reassess our continuing involvement in secondary activities.

The decisions to be contemplated by our organisation may not meet with the universal acceptance of our membership or the wider community, but cannot be deferred given the inadequacy of current income levels. We signal that cutbacks will be necessary in both the scope and scale of Association activities to ensure sufficient resources are available and directed to maintain frontline patrol activities.

In spite of the current constraints the Association has a vision for the future. The Executive has recently met to give preliminary consideration to future year needs. Initiatives currently under way involve :

- a wide ranging review of the movement's information technology requirements, covering financial reporting, donor and membership databases, statistical and education records.
- preparation of a newly formatted Strategic Business Plan.
- formalising a strategic alliance with Surf Life Saving Queensland.
- development of an accounting bureau for affiliated clubs.
- implementation of a professional marketing strategy and identification of communications partners.

The 1994 Annual General Meeting heralds the introduction of new management structures for the Association. Clubs have recently approved alterations to the constitution establishing separate elected Boards to oversee lifeguarding activities, and competition series'. Management - or the Executive Board as it will be known - has been reduced in size and will assume responsibility for all matters pertaining to policy, strategic planning, and financial management.

This reconstruction, and the current fiscal planning process, is the culmination of five years effort during which the Association has returned to its primary activity, beach patrols and inshore rescue. Many have contributed to this process, not the least Graeme Danks who is standing down after five years on Management, the last three as Chairman. It is appropriate to acknowledge Graeme's guiding role, and resolute determination that the clubs come first. His belief that the Association should be lean and responsive to the needs of clubs and the beach going public is reflected in the new structures.

Clubs, the membership themselves, and the community we serve must adapt to and accept that the delivery of lifeguarding services will be more business like, and less philanthropic. 1994/1995 will be an interesting, challenging transitional year.

It is important we recognise the vital role surf sports play both attracting and retaining membership and it's importance in boosting our public profile through continued media coverage.

This is my second report as District Superintendent and the last before the current management structure changes to the Board of Life Saving and the Board of Surf Sports. I ask all lifeguard to assist in the transition to this new and necessary structure.

My thanks must go to Lion Red for without your financial assistance and support the standard of Auckland lifeguarding would not be at the level it is today.

My thanks to Chairman Graeme and fellow members of management. To Tim Jago and his staff for their continued support and assistance. To Surf Life Saving New Zealand and our resident National Development Officer, Willy Heatley and to all the team managers, the lifeguards for your continued support and co-operation.

Finally to the many members of the Board of Judges & Examiners for your untiring energies in what has been a busy and difficult season. My special thanks to Gordon Morris for your support. I look forward to seeing everybody on the beach in the new 1994/1995 Surf Life Saving Season.

Radio Communication

This season saw the installation and commissioning of a brand new, latest technology radio communication network. The complex network was made possible by the Lottery Grants Board's one-off donation of \$225,000. On receipt of this money our radio consultants Johnston Dick & Associates were commissioned to complete the system design and call for quotation for supply of the equipment. Motorola NZ Limited were awarded the contract for the supply of all equipment and the target date for installation by Labour Weekend 1993 was by and large met. Between Labour Weekend and Christmas the network was brought to a very fine performance standard where all clubs could communicate with each other and the radio base, with clarity unheard of previous to this. We are very thankful to Warren Harding of Johnston Dick & Associates who put in long hours, many of which were often in his own time, and who regarded our system as his baby and who was not satisfied until the network was brought to exacting broadcast standards.

It now rests with clubs to ensure the radio gear at the club is cared for in an appropriate manner and to the Association to provide for the ongoing maintenance.

Early in the new season the emphasis will turn to training all clubbies how to operate and get the most out of the equipment.

Professional Guards

A very successful programme was run this year under the guidance and control of Kevin Backhouse-Smith. Selection trials this season were held at Karekare and in retrospect this may be reviewed next season as there were a number of probably very competent prospective guards who were not comfortable displaying their skills on a West Coast beach when their aim was to patrol the East Coast. However, our aim to employ only the very fit, fully qualified and skilled guards was largely achieved. As mentioned elsewhere in this report the summer of 1993/1994 produced record crowds and this resulted in record numbers of rescues. The professional guards bore the brunt of this extra work and especially on popular beaches patrolled long hours, many in their own time. We are mindful of this and as funds permit hope to correct this situation. Only one complaint was received regarding our guards and this was of a relatively minor nature and Management overall are very pleased with the guarding programme.

The funding of the programme is still a problem. Dealing with a multitude of local authorities is a problem. However, it is fair to say we have very many supportive friends amongst our councils and we are well aware that councils are under extreme pressure from many areas for funding. Still, the funding for a full programme was not available this year. Again full manning was not able to be provided and the patrolling season for the professional guards was shortened to fit the budget. This cannot continue and I believe it was only the professionalism of our guards and their dedication and sense of public service that allowed for the huge crowds to be guarded without any major incidents.

JUNIOR LIFEGUARDS

Another extremely busy season passed us by with the weather on our side, participation carnivals had strong representation from most clubs, with keen members doing their best to maintain smooth running on the day.

Carnivals were hosted by Red Beach, Orewa, Ruakaka, Piha and Omaha providing a wide range of challenges and experiences for our Junior guards.

To cater for the wide range of abilities challenging new events were introduced for those wishing to participate :

- Ruakaka provided an optional longer swim distance for those more confident and capable in this event.
- A run-swim-boogie board/blue board event.
- An Iron person and long distance run proved popular at the beginning of the season.
- Nine year old, 200m badge holders were able to use blue boards
- The 200m re-qualification was held as an event
- Biathlons were introduced.

Participants enjoyed the variety of events with the option of moving into the age group where they felt confident.

The weekend carnival held at Piha proved to be a huge success with a moderate west coast surf rolling in. Mention must go to those who helped provide such a weekend, especially Alan Seagar and Penny Joyce.

The Eddie Millar Cup was contested for at Omaha in very difficult trying conditions. Despite adverse publicity the day proved to be very enjoyable. Clubs provided 24 person teams to compete against each other. With very close and tense competition Red Beach narrowly held the cup from Muriwai with Piha and Mairangi Bay not far behind.

The Kiwisurf Sunsmart Youth Festival was another great weekend with massive organisation by all involved. Stanmore Bay was an ideal venue and once again Auckland put on the weather. Clubs from as far as Taranaki made the eight hour bus trip to take part in the Festival. All returning home safely after a fun packed weekend.

Lastly without the expertise and help from parents and interested parties Junior guards would not survive. A big thank you to all who were involved over the 1993/1994 season. Hope to see you back again next season.

POWERCRAFT CONTROLLER

Inflatable Rescue Boat's (IRB's) are the number one piece of rescue equipment on Aucklands patrolled beaches, being responsible for approximately 70% of the rescues performed. This is an increase of 10% from last season. The Association has continued to help train and qualify IRB operators and crew. In the light of the Health and Safety Act a new and improved training scheme is currently being planned. This act, along with Maritime Safety Regulations, will affect all personnel involved in IRB rescue work in the future and the need to be pro-active is important.

In the future the funding for clubs will be dependent on the needs of the club, the role they perform in saving lives and the quantity of well trained lifeguards in their club. This funding philosophy will ensure that overworked clubs get sufficient funding to do the work. It also raises the prospect of clubs pushing ill trained lifeguards into gaining quick qualifications for funding purposes. All clubs need to be aware that the gaining of an IRB crew and operators certificate

will require a much more professional attitude from candidates and instructors in the coming seasons. The lifelong operator's certificate is likely to be a thing of the past and re-qualification every 3-5 years a real possibility. The aim is not to make it more difficult to get but to make sure that everyone who does gain this certificate understands the responsibilities that go with it.

The ASB's substantial contribution to the Association will go a very long way toward helping clubs purchase fully equipped IRBs. This means that the Association is able to reduce its fleet of IRBs, the monies saved being re-directed to the training and education of IRB crew. The ASB's contribution will ensure that the IRB fleet in the Auckland district will remain modern and Aucklands share of the BP fund, distributed by our national body, remains totally out of proportion to our work load and will be mostly used to help pay for all costs of insuring the Auckland districts fleet, training, and the hull replacement scheme.

The Waitakere Licensing Trust is providing fully equipped IRB's, along with other equipment, to Karekare, Piha, United and Bethells over the next four years. Their support of the clubs in their area in this way is as demonstration of the sort of relationship that ought to exist between all licensing trusts throughout New Zealand, and the communities they serve. "AEG Lifeguard" and its crew represented the Association at many special events including the Whitbread fleet's arrival and departure, swimming legs of triathlons and biathlons, Anniversary Day Regatta, the cleanup of the water-ways around the Te Atatu area, Americas UEB Cardboard Cup, offshore power boat racing and fishing competitions. It is on duty almost every weekend including the winter and has been involved with rescuing other boats, searches and general patrol work. It has also been involved in transferring MAF officials to foreign fishing boats. Some of these events are done for love but the others are done at commercial rates which keep the boats existence viable.

Piha hosted the very successful Auckland IRB Championships in early April. While entries were low the competitors demonstrated excellent skills, only one injury and one gear breakage, and all involved had a great time. Our Marketing Manager secured excellent sponsorship from Matua Valley Wines, Johnson Outboards (OMC), and CRC Industries in the form of money and product which was given out in addition to medals.

The Public Relations Committee comprising Ross Maylon, Graeme Ahern and Neil Reid, has

met regularly to assess the broad spectrum of public relations initiative and policies of the Association. These gentlemen have also spearheaded competition publicity, and are each personally responsible for a large amount of coverage. A huge amount of press and radio coverage is testament to another season of efforts by club public relations officers.

The only real rewards these people get for doing this job are intrinsic. But take satisfaction that your cumulative efforts are constantly commented on by the Association Management, sponsors and those in the industry. There are countless corporates out there with phone number sized public relations budgets who would kill for the rapport we have with the media through the region.

At the time of writing the proposed new Association management structure will swallow the Public Relation's Officer's portfolio in to the position of Director of Marketing and Publicity. This is a logical step in formally integrating two activities which by nature co-exist. The club will pay the fees for anyone who wants to attend these courses. In time, this will reduce the pressure on senior members. We must also continue to recruit and train new members.

Finally, let's not forget that we perform a public service, and an important one. I have no doubt that people would die at Kariaotahi if we were not there. We should all feel satisfied with having done a good job. Service others seems to be going out of fashion, but it is immensely rewarding for those who do it.

Last I would like to thank Russell Blomquist, Simon Bruce and Steven Hersey for the amount of work they have put into the club this season both on the beach and in club management.

After the improvement in performance achieved last year it is disappointing to have to report a loss of \$175,587 in the year just ended. The major cause is highlighted on the Activity Statement where expenditure has exceeded income by \$129,672. In 1993 the Association was able to generate net income of \$48,996 from activities. This means that there has been an adverse turnaround in performance of \$178,668.

REPORT ON FINANCES



The 1993 figures covered a 14 month period when the Association changed its balance date to 30th June. Revenue in 1993 included \$125,853 from gaming machines which were disposed of part way through that year. Gaming machine net income had been over \$50,000 in 1992 and the loss of this revenue has been felt by the Association since this time.

Excluding the gaming machine revenue and adjusting for one offs the 1994 revenue is a little below the 1993 level with Powercraft showing the largest drop.

It is in the area of expenses that costs have risen most significantly. In part some of this expenditure was on equipment and maintenance and will not be repeated in 1994/95. In part the increase reflects a reallocation of salary costs formerly charged to administration. This has been done to more accurately show the true cost of our various activities. The major part of the increase however seems to relate to the higher level of activity to meet the demands by the associated clubs for additional services.

In the competition area there has been an increase in expenditure on equipment in this year. This is not expected to be repeated in 1995.

Contract life guarding expenditure includes outgoings on signage, advertising, etc., uniforms and other purchases. While revenue increased the improvement was below the level necessary to recover the costs of this service provided to the Local Bodies.

The Marketing and Publicity area has reported a negative contribution. In part this is because of the allocation of the marketing officer to this account. The costs of running a major appeal are high and revenue has not been adequate in relation to the expenditures incurred including those relating to keeping in touch with our supporters.

A review of fundraising activities will be carried out in association with the Surf Trustees and will commence almost immediately.

Patrol Skill and Development activities included the USA trip which has cost the Association a net \$21,000. The trip generated revenue of \$39,000 which accounts for virtually all the increase in income reported.

It is now clear that examination fees are falling well short of recovering the costs involved and this situation will be reviewed for the 94/95 year with the aim of examinations becoming self funding.

Powercraft sponsorship has fallen while costs have only dropped slightly. It seems clear that clubs will have to bear a greater share of the costs of this equipment which is held by the Association to provide a back up for their own craft.

The radio network was replaced during the year and radio has made a small contribution. The higher depreciation reflects the cost of the new equipment. Maintenance costs have fallen as expected.

Club support revenue includes the first part of the ASB administration grant in addition to the regular BP funding. Club support was not shown separately in the 1993 accounts and has been split out to show the amount of funding provided directly to the clubs.

The Surf Trustees have increased the grants to their Association which totalled \$92,900 in the year just ended. With donations and legacies being significantly up on 1993 levels other income totalled \$276,677 for the year.

Administration expenses are much in line with 1993 and require no comment other than for printing and stationery which costs include the annual report and other sundry items. Printing and stationery costs have risen substantially both in administration and in the various activities reported. Some of these costs are for material useable in the 1994/5 year.

A change in the basis of reporting has been highlighted in the annual accounts. Previously grants made to the Association to enable the purchase of specific equipment were taken up as income.

With the introduction of the ASB Charitable Trust as a major sponsor and the receipt of funds from NZ Lotteries Commission for the radio network it was decided to show such monies as capital grants. These are reported below the figure for the excess of income over expenditure. The total of such monies was \$246,123 in the 1994 year.

We have taken the opportunity to review older items of plant/fixed assets and to write off balances shown in the fixed asset schedule for equipment owned for a number of years that could not be specifically identified. This write down is included in the figure of \$78,652 shown immediately above the capital grants received. The bulk of this amount however, (\$41,889), relates to the net book value of the radio equipment replaced. This equipment was surplus to requirement following the installation of the new system and in fact was taken over by the supplier to be used for spares.

The balance sheet shows a significant reduction in liquidity with creditors increasing to \$199,996 and the Bank overdraft to \$70,206.

It is clear that the Association cannot sustain another year's loss of this magnitude. There is an urgent need to access funds to improve liquidity and make up the losses reported not only in the 1994 but the 93 and 92 years.

The Surf Trustees have indicated that they are prepared to assist the club subject to certain understandings. In addition we are actively pursuing assistance/grants from local bodies or other sources of monies for organisations of this type. Any additional funding that can be obtained will have to be utilised to clear past losses and improve the cash position.

The Budget for the 94/95 year has been reviewed and now amended to produce a break even position. Comments have been made elsewhere in the report about the responsibilities facing the incoming management group. There will certainly need to be a curtailment of activity from the levels reported in the 1994 year.

I would not like to end on a negative note however. The work done by the Association in the last year has generated considerable goodwill and support. The outside funding and particularly the ASB sponsorship represents a significant achievement and will have helped place member clubs in a strong financial position. Our next priority must be to achieve the same result for the Association.

TRUSTEES

Trustees have met regularly throughout the year and all meetings have been attended by senior Association management which ensures strong ongoing dialogue between the Trust and the Association.

The Trustees in recent months have given much attention to fundraising strategies for the Association and the Trust. The Association has an established large database of past donor and has neither the computer facilities nor the software to maximise the use and control of the stored donor information. In this connection the Trust is supportive of new systems being developed to ensure the ongoing productive use of the donor lists.

A residential property at Piha Beach owned by the Association for some years was transferred to the Trust in December 1992 and agreement was later reached and the property was no longer a strategic asset and its sale would facilitate the purchase of additional stocks and shares.

An investment review of the Grafton Road property resulted in the decision to retain the property until the present lease expires in October 2001, at the time the property could be expected to realise a significant gain over this current market value. Alternative investments available now to the trust would not realise the present income and capital gain projections. During the year the exterior of the building has been painted.

The investment portfolio shown elsewhere in this report in detail has been regularly reviewed throughout the year with some profits taken and additional investments purchased. CS First Boston is retained by the Trust as its investment advisers. It has been a difficult year for the investment markets particularly in the last quarter where overseas influences, particularly USA, have reacted unfavourably on the NZ markets. Long term prospects are more favourable and the trust is confident in its portfolio.

At the end of the financial year the investment of funds and income is spread as these graphs show (both expressed as percentages of totals) with comparative figures for the previous financial year.

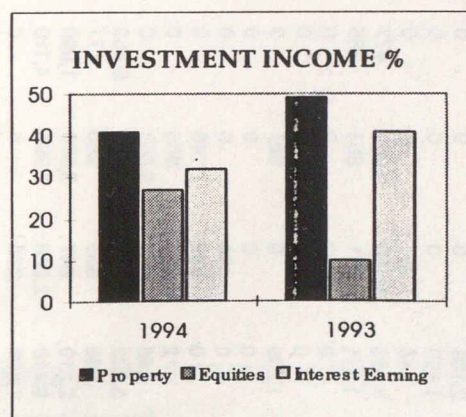
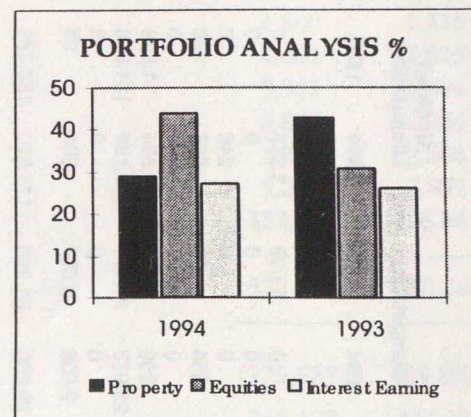

1. STATEMENT OF ACCOUNTING POLICIES

A) GENERAL ACCOUNTING POLICIES

The measurement base adopted is that of historical costs. Reliance is placed on the fact that the Association is a going concern. Accrual accounting is used to match expenses and revenues.

B) PARTICULAR ACCOUNTING POLICIES

The following particular accounting policies which materially affect the measurement of profit and financial position have been adopted :

Accounts Receivable

Accounts Receivable are stated at expected realisable value after due allowance for bad and doubtful debts.

Inventories

Inventories are stated at the lower of cost, using a first-in, first-out basis, and net realisable value.

Fixed Assets

Fixed Assets are stated at cost and depreciated at the following rates :

◦ Examination & Instruction	20% / 25% DV
◦ Furniture & Fittings	20% DV
◦ Gear & Equipment	20% / 25% DV
◦ Inflatable Rescue Boats	20% / 25% DV
◦ Motor Vehicles	25% DV
◦ Office Equipment	20% / 25% DV
◦ Radio Equipment	20% / 25% DV
◦ Trailers	20% / 25% DV

Goods & Services Tax

The financial statements have been prepared using GST exclusive figures.

Taxation

The Association is exempt from tax under Section 61 of the Income Tax Act 1976. Donations made to the Association qualify for a tax rebate within the limits imposed by the same Tax Act.

C) COMPARATIVE FIGURES

Last year the Association's balance date was changed from 30 April to 30 June to align itself with the National body. Comparative figures for the past year are for a fourteen month period unless otherwise stated.

D) CHANGES IN ACCOUNTING POLICIES

Apart from the change in the treatment of capital grants, (see Note 7) there have been no other changes in accounting policies and these have been applied on bases consistent with those used in previous years.

2. NATURE OF BUSINESS - SEGMENTAL REPORTING

The Association is responsible for the provision and administration of life saving activities within the Auckland region.

5. ASSOCIATED TRUSTS

In November 1992 the assets of the Auckland Surf Life Saving Association Appeal Trust were vested in the Association and then immediately transferred to a new Trust, the Auckland Surf Life Saving Trust Board Incorporated.

At the same time the Piha Lodge property which was owned by the Association was transferred to the new trust.

6. FIXED ASSETS WRITTEN OFF

During the year assets which were considered to have reached the end of their useful life was written off. These totalled \$36,763. In addition a further \$41,889 of Radio Equipment became redundant with the installation of the new radio network. This equipment was taken by the contractors and has been written out of the books. The total written off was \$78,652. This has been shown after the operating loss for the year together with capital grants made to the Association.

7. CAPITAL GRANTS

During the year the Association received grants from the NZ Lotteries Commission Board totalling \$191,889 for replacement of radio equipment and from the ASB Charitable Trust of \$29,839 for specific capital equipment.

Previously grants of this nature were taken up as income in the year received. Capital grants are now expected to form a regular and significant part of the funding used by the Association and have therefore been separated from the main operating statement. The funds are specifically identified (and set aside) for the purchase of plant and equipment used by the Association.
